- Maintain contact with No Limits as your group implements the mini-grant and recruitment plans
- Update No Limits with any changes/additions/cancellations of mini-grant activities
- Encourage youth to follow through with plan as outlined at summit
- Serve as the fiscal agent of the mini-grant funds/toolkits
- Oversee mini-grant final reports and see to it that all paperwork is turned in, and in a timely manner

WHEREAS, the possession and/or use of weapons, tobacco products, alcoholic beverages and illegal drugs, or remaining in the presence of individuals who are using or taking these items is prohibited; and

WHEREAS, sexual contact at any event or activity which occurs within the time frame of the No Limits Activism Summit is prohibited; and

WHEREAS, any behavior that violates any of the laws of the United States or the State of Nebraska or any local ordinance is also prohibited; and

WHEREAS, the attendance and punctuality at all scheduled sessions at the summit is considered mandatory by all participants at the No Limits Activism Summit; and

WHEREAS, all participants are expected to show respect for the property of others and the facility in which the meeting is being held; and

WHEREAS, all water activities including, but not limited to, the use of the lake, hot tub, Jacuzzi, or swimming pool facilities, swimming, boating, tubing, etc. at any event or activity within the time frame of the No Limits Activism Summit are prohibited; and

WHEREAS, all sponsors, groups, and individuals are expected to remain at the No Limits Summer Activism Summit for the entire duration of event, which is being held primarily at Leadership Center. (However, the group will travel to various locations for activism purposes and sponsors must remain at these locations with their youth.)
